In addition, the company group that has management control of KKJ, has no shareholdings in any of CBIP's oil palm operations under CBIP's management control. In fact, KKJ, has at company group level, been very supportive of Wilmar's No Deforestation, No Peat, No Exploitation (NDPE) policy implementation, participating actively in our supplier compliance and verification programs. Wilmar has previously conducted ground verification in two mills under the KKJ group since the launch of our NDPE policy in December 2013. Our last visit to a KKJ operation was in May 2019. |
