# Progress of Community Conflict cases in West Sumatra

As of end October 2019, there are currently 3 active RSPO complaints cases involving Wilmar in West Sumatra, Indonesia. We are currently cooperating with the RSPO complaints desk and the IMU to ensure that the cases are handled well and with accountability. A summary of the cases can be found below, with full details on both the RSPO complaints tracker<sup>1</sup>, and the Wilmar grievance dashboard (RSPO complaints listing)<sup>2</sup>.

Despite delays in the process, Wilmar continues to be fully cooperative and open with the investigations being conducted by the RSPO.

#### Court case linked to complaint case of PT PMJ

On 29th October 2010, the Dastra Village Cooperative (KUD Dastra) plasma smallholders partnering PT Primatama Mulia Jaya (PT PMJ), brought to the company's attention that their plantations were being trespassed and the oil palm in their estates were being illegally harvested by Syahrul Ramadhan Tanjung.

There has been a longstanding land dispute between KUD Dastra and Syahrul Ramadhan Tanjung, who claims the title of leader of the Nagari Simpang Tigo Koto Baru indigenous people. PT PMJ subsequently lodged a police report, on behalf of KUD Dastra to seek legal recourse for the continuous trespassing and illegal harvesting of their crops.

However, the trespassing and illegal harvesting continued for the next seven years till 2017, at which point, KUD Dastra smallholders requested PT PMJ to escalate the matter to the regional police. This led to a comprehensive investigation which resulted in the apprehension of Syahrul Ramadhan Tanjung and his associates.

He was then trialled at the district court for charges of looting and after careful examinations of the evidences brought before the courts, he was found guilty and given a nine-month jail sentence. Subsequent appeals to the High Court and the Supreme Court upheld the guilty verdict.

There is an ongoing grievance case with the RSPO (see above case related to PMJ) and is currently undergoing the relevant due process, of which all parties involved are awaiting for its outcome as well as the proposed next steps for resolution.

Forest Peoples Programme (FPP) published a statement on December 2018<sup>3</sup> alleging Wilmar's criminalizing of community leaders in the West Pasaman region, specifically highlighting Syahrul Ramadhan Tanjung. Wilmar refutes the allegations of criminalization, which the statement heavily implies was used in response to Syahrul Ramadhan Tanjung raising the complaint.

#### Making progress on resolving existing conflicts

Wilmar has strict policies and procedures in relation to protecting Human Rights Defenders, regardless of their claims or campaign. Further we are currently developing with CORE, and NGO stakeholders on developing a specific No Exploitation grievance mechanism to improve the handling of grievance cases (for Wilmar and all our suppliers) can be made consistent with globally recognized guidelines.

Further to that, through our collaborative efforts with conflict resolution expert in the region, Wilmar has been closely engaging the affected members of the community in order to identify and develop a long-term resolution that is mutually agreed upon and beneficial for all parties. A report on the current work in the region will be made public in November 2019.
